

# **General Terms and Conditions for Participants**

For the event:

18th CIMT Annual Meeting

Date: May 10-12, 2021

Place: Mainz, Germany (live stream)

Please note the following information and terms and conditions for participation in the event mentioned above. The host has commissioned wikonect GmbH, Hagenauer Straße 53, 65203 Wiesbaden to organize the event. The registration fee will be charged by wikonect GmbH in the name and on behalf of the host and will be transferred to the wikonect account.

Participation is reserved for physicians and researchers. To participate in the live stream, further free-of-cost registration on the online congress platform to be used may be required.

### Terms of payment and cancellation

Registration fees must be paid by credit card (Visa and MasterCard) and will be due upon completion of the registration process and the resulting binding registration. Invoices for participation in the event will be sent to the participant via email and will bear the participant's name and invoicing address as indicated during the registration process.

Groups may only be registered after contacting wikonect. Payment of the group registration fee is due immediately upon issue of the invoice after registration and must be made no later than 14 days before the start of the live stream. The invoice amount must be transferred to the account stated on the invoice (please state the name and invoice number indicated on the invoice when transferring the invoice amount). Any bank and/or bank transfer fees incurred for the transaction must be borne by the participant.

Students wanting to register at the reduced student rate need to provide written proof by their university/faculty confirming their student status. Such confirmation must be sent to wikonect not less than 7 days before the start of the event. After expiration of this deadline, the previously granted reduction will automatically be charged retroactively.

If you need to change your registration, please contact wikonect by email. Please note that you register in your own name, and that your registration cannot be transferred to a third party. If you cancel your registration up to 14 days prior to the event, you must pay a cancellation fee in the amount of €50.00. If you cancel your registration after this date, the invoice amount will not be reimbursed. The full registration fee will also be due if a registered person fails to participate in the event. Please note that cancellations can only be accepted if in writing.

All prices are quoted inclusive of statutory VAT (value added tax).

### Changes and cancellation of the event by the host

The event/live stream will only take place if minimum attendance numbers are reached.

The host reserves the right to replace speakers, change the date, cancel sessions or change the program. If the event is cancelled, fees already paid will be reimbursed in full. Any further claims for compensation shall be ruled out.

### Availability of live streams and digital event documents

The live stream can only be accessed after receipt of the registration fee and upon the start of the event. More information will be published on our website in due time.

If access to on-demand videos of the lectures is to be provided, these will be successively made available on the online congress platform about 2 weeks after the respective event / live stream and can be retrieved from there for a period of 1 month. Participants will be informed about the on-demand videos' availability provided that they have given wikonect their correct email address.

### Copyright and image rights

Posters, graphics, lectures are usually protected by international copyright laws. Each lecturer warrants that he holds the rights of use to the items used during his lecture (texts, photographs, graphics). It is not permitted without express prior authorization by the author(s) to take pictures of posters, graphics, people, etc., and to transfer these pictures to third parties via social media (Facebook, twitter, etc.) or webpages. #### Liability notice
