# **General Terms and Conditions for Participants**

For the event:

2022 CIMT Annual Meeting

Date: May 10-12, 2022

Place: Mainz, Germany and live stream

Please note the following information and terms and conditions for participation in the event mentioned above. The host has commissioned wikonect GmbH, Hagenauer Straße 53, 65203 Wiesbaden, Germany, to organise the event. wikonect GmbH will charge registration fees, which are to be transferred to the respective account of wikonect GmbH, in the host's name and for the host's account.

To access the live stream, you will have to re-register on the platform free of charge.

### Terms of payment and cancellation

Payment of the registration fees shall become due on completion of registration and the resulting binding booking and must be made no later than 14 days before the start of the on-site event/live stream. Payment can be made by credit card (Visa and Mastercard) and advance bank transfer. Invoices will be sent to the participant via email, bearing the participant's billing address as stated in the registration form. We kindly ask you to pay the invoice amounts free of charge after receipt of the invoice, stating your name and invoice number. Any bank and/or bank transfer fees incurred for this transaction must be borne by the participant. Groups may only be registered after contacting wikonect. Payment of the group registration fee is due immediately upon issue of the invoice after registration and must be made no later than 14 days before the start of the on-site event/live stream. The invoice amount must be transferred to the account stated on the invoice (please state the name and invoice number indicated on the invoice when transferring the invoice amount). Any bank and/or bank transfer fees incurred for the transaction must be borne by the participant. Students wanting to register at the reduced student rate need to provide written proof by their university/faculty confirming their student status. Such confirmation must be sent to wikonect not less than 7 days before the start of the event. After expiration of this deadline, the previously granted reduction will automatically be charged retroactively.

If changes to the registration are necessary, please contact wikonect GmbH via email. Please note that a processing fee of €10.00 will be charged for invoice corrections. Registrations are made on a personal basis and are non-transferable.

If you cancel your registration up to 14 days prior to the event, you must pay a cancellation fee in the amount of €50.00. If you cancel your registration after this date, the invoice amount will not be reimbursed. The full registration fee will also be due if a registered person fails to participate in the on-site event, or if

persons have registered for the live stream but have not accessed the live stream without prior cancellation. Please note that cancellations can only be accepted if in writing.

A fee of € 20.00 will be charged for any changes made to the booking (e.g. change from on-site event to live stream and vice versa). Any difference in registration fees will be reimbursed or billed subsequently. An on-site event booking can be changed to a live stream booking up to 14 days prior to the start of the on-site event, subject to availability (number of registration spots for the on-site event is limited due to Corona restrictions).

If the participant cannot participate in the booked on-site event due to force majeure (such as the Covid-19 pandemic), or if the on-site event is cancelled, the live stream can be booked free of charge. Any differences in registration fees will be reimbursed.

All prices are quoted inclusive of statutory VAT (value added tax).

## Changes and cancellation of the event by the host

The on-site event/live stream will only take place if minimum attendance numbers are reached.

The host reserves the right to replace speakers, change the date, cancel sessions or change the program. If the on-site event/live stream is cancelled entirely, the host will inform the participant immediately. In this case, any fees that have already been paid will be reimbursed in full.

If individual parts of the program, which were booked and charged separately (e.g. seminars, courses etc.) are cancelled, the respective fees will be reimbursed.

# Availability of live streams and digital event documents

Access to the live stream will only be granted after receipt of the registration fee and upon the start of the event. More information on the start of the live stream can be found on the relevant pages of our website.

### Copyright and image rights

Posters, graphics, lectures are usually protected by international copyright laws. Each lecturer warrants that they hold the rights of use to the items used during their lecture (texts, photographs, graphics). It is not permitted without express prior authorization by the author(s) to take pictures of posters, graphics, people, etc., and to transfer these pictures to third parties via social media (Facebook, twitter, etc.) or webpages. The person taking the pictures must be able to provide proof of such authorization by the author(s) (e.g. author's mail). Protected material may only be used if the author(s) is mentioned by name. Each participant agrees to indemnify the congress organizer and conference host against any claims for damages by third parties arising from the infringement of any rights by the participant.

Liability for contents

The information and comments provided during the on-site event/live stream are for informational

purposes only and do not substitute consultation with a physician.

Liability notice

The host of the event shall be liable without limitation for damages to congress participants resulting from

injury to life, limb or health caused by a breach of duty of its legal representatives, employees or vicarious

agents. For other damages to the congress participants, the host shall be liable without limitation only in the

case of intent and gross negligence of its legal representatives, employees or vicarious agents. The host

shall not be liable for cases of ordinary negligence of its legal representatives, employees or vicarious

agents, unless an obligation is violated, the observance of which is of particular importance for the

fulfilment of the contractual purpose (cardinal obligation). This shall include such obligations, the fulfilment

of which is essential for the due and proper execution of the contract, the breach of which endangers the

fulfilment of the contractual purpose, and the compliance with which the other contract partner regularly

relies on. In the event of a negligent breach of a cardinal obligation, liability shall be limited to the

foreseeable damage typical of the contract.

Third party regulations / house rules

Express reference is made to separate third-party provisions, in particular to the house or cloakroom rules

and regulations of the venue operator.

Access ruling

Only expert participants will have access to the event facilities; all other persons and pets (except guide

dogs) will not be admitted.

For legal reasons, children over the age of one will not be admitted to the congress facilities. Infants under

one year of age can be taken into the event facilities if accompanied by their parents or legal guardians.

If it is necessary to bring children under the age of one into the venue, this will only be permitted if they are

under the constant supervision of an adult, and if the limited access rights are complied with.
